

## **OFFICIAL DRAWING. The official drawing will take place on September 30, 2017**

### **2017 Car Raffle Rules:**

1. **TO ENTER.** From March 22, 2017 to September 30, 2017 or until 4500 to 5000 tickets have been sold, ("Entry Period"), entrants may enter the FPH Auxiliary Ford Fusion Raffle ("Raffle") by purchasing a raffle ticket from an authorized volunteer or designated location for \$25 each. Additional information regarding the Raffle may also be found online at [FPHAUXILIARY.org](http://FPHAUXILIARY.org).
2. The Raffle is sponsored by Auxiliary of the Foothill Presbyterian Hospital Morris L. Johnston Memorial (the "Raffle Sponsor"). The Raffle Sponsor's primary purpose is to support, promote and advance the welfare of the Foothill Presbyterian Hospital – Morris L. Johnston Memorial, a 501 (c)(3) tax-exempt nonprofit corporation. All decisions of the Raffle Sponsor are final.
3. **CONDITIONS.** An eligible entrant may only enter via the ticket purchasing methods as described above. Only one individual's name may be associated with each ticket. Incomplete entries are void. By entering, entrants acknowledge compliance with these official rules including all eligibility requirements. All entries become the property of the Raffle Sponsor and will not be returned. Neither Raffle Sponsor nor advertising and promotion agencies are responsible for incorrect or inaccurate transcription of entry information, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. No copies, facsimiles or reproductions of entries will be accepted.
4. **DETERMINATION OF WINNER.** A random drawing will be conducted at Glendora, CA from among all eligible entries received. The FPH Auxiliary Ford Fusion Raffle drawing will be held from all eligible entries received. Winner need not be present or in possession of ticket stub to win. Drawing will be open to the public. Drawing date and location (in Glendora, California) will be uploaded on the [FPHAUXILIARY.com](http://FPHAUXILIARY.com) website once determined.
5. Odds of winning depend upon the number of eligible entries received, not to exceed 4500 to 5000 tickets sold. The winner will be notified by telephone and/or email. The winner will be required to complete an affidavit of eligibility and release, which must be completed and returned within three (3) days of issuance of notification; otherwise, an alternate winner will be selected. Any attempt to deliberately damage the content or operation of this Raffle is unlawful and subject to legal action by the Raffle Sponsor or its agents. **TICKETS (PRIZE) ARE**

NON-TRANSFERABLE AND CANNOT BE SOLD.

6. **PRIZE.** The prize is a brand new 2017 Ford Fusion with an estimated value of \$41,000. Raffle Sponsor reserves the right to substitute a prize of comparable or greater value, if a prize cannot be awarded for any reason.

7. **ELIGIBILITY.** The Raffle is open to legal residents of the United States who are 18 years of age or older as of December 12, 2016. The Raffle is void where prohibited.

8. **WINNER'S NAME.** For the name of the prize winner, send a self-addressed, stamped envelope to: FPH Auxiliary, 250 S. Grand Ave., Glendora, CA 91741

9. **RULES REQUESTS.** To receive a copy of the official rules, send a self-addressed, stamped envelope to the same address listed in Item 7.

10. **TAXES.** The fair market value of the prize is the value of the car, plus taxes and license. All applicable federal, state and local taxes associated with winning the prize in the Raffle will be the sole responsibility of the winner. The Raffle Sponsor will collect 28% of the fair market value of the prize from the winner that is a California resident\* to remit to the IRS for "withholding" tax. The winner will be provided an IRS form W-2G which reports the value of the prize and any withholdings.

11. **LIMITATIONS ON LIABILITY AND DISCLAIMERS.** Raffle Sponsor, its directors, employees, officers, or agents will not be responsible for or liable to any prize winner, winner's family or estate for any submissions of entries that are lost, late, illegible, damaged, incomplete, or incorrect.

12. Raffle Sponsor can, at any time it chooses, without recourse, decide to terminate or modify the Raffle if the integrity of the Raffle appears to be compromised. If the raffle is cancelled, all monies paid for raffle tickets will be returned to entrants. Decisions of the Raffle Sponsor related to the winner, interpretation of official rules, and other matters related to this Raffle are final.

13. **GOVERNING LAW.** This Raffle is subject to all applicable federal, state and local laws. All disputes surrounding the Raffle and any prize awarded hereunder will be subject to the substantive laws of California. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

14. **GENERAL.** Winner consents to the use of his or her name, biographical information, photographs and/or likeness for advertising and publicity purposes without additional compensation, except where prohibited. Raffle Sponsor

reserves the right to verify eligibility qualifications of the winner. Purchased tickets are not tax deductible, nor considered a donation to the Raffle Sponsor.

Raffle Sponsor makes no warranty of any nature with respect to the raffle or the prize, whether in respect of fitness for a particular purpose, satisfactory quality or otherwise. Entrants acknowledge that, except as specifically set forth herein, Raffle Sponsor has not made and disclaims all liability for any warranty, representation or guarantee, express or implied, in fact or in law, related to the raffle or the prize. All entrants, by entering, agree to be bound by these official rules. By accepting the prize, winner agrees to release Raffle Sponsor, its directors, employees, officers or agents, from any and all liability, loss or personal or property damages arising directly or indirectly out of, or in connection with, the awarding, receipt, accepting, using or misusing of the prize or participation in any prize-related activities.
